No Further Action: This case relies heavily on the statements of the victim. A thorough investigation by Sgt. Andrews lead to numerous contradictory statements by the V that cannot be explained. The affidavit the V filed to obtain a PFA describes almost a completely different time line and type of sexual assault than V described to Sgt. Andrews. Most concerning is that Sgt. Andrews was present in the ER when V was told that the CT scan did not show any soft tissue damage or swelling. The medical records confirm this information. The ER visit took place before V obtained a PFA. However, V wrote in her sworn affidavit that he scan did show soft tissue damage and swelling. There are too many contradictory statements to detail in this NFA notice. Once all the contradictory statements are introduced at trial it is highly unlikely the jury could come back with a guilty verdict.

In early July, ADA Katie Dakers contacted me and told me that at the request of DA Jonathan Sarhbeck, this case was going to be referred to another prosecutorial district, and that I should expect a call.

On May 29, 2020 I received a notification from ADA Dakers that the case was not moving forward. Det. Eugene Gallant had delivered the sex crime forensic kit to the MSP Lab on 5-27-20. I notified Det. Eugene Gallant that the case was closed. He notified the Maine State Police Crime Lab that the kit could be removed from the processing queue. On 6-12-20 Det. Gallant received the kit back from the lab and secured it in evidence at the police station. On 6-16-20 the kit was discarded

8-27-20

I received a call from ADA Alexandra Winter from the Oxford County District Attorney's Office. ADA Winter explained that she had reviewed the case documents and spoken to Sarah Petrin. ADA Winter asked that I do some follow up on the case. She asked that I speak to the male that exchanged text messages with Diffin on the evening of the assault. ADA Winter said that she learned from Petrin that the male in question was now her boyfriend and would be willing to speak to me. She also stated that she learned from Petrin that when talking about the assault at her place of employment, a co-worker named Sylvia O'Connor asked "was it Wayne?. ADA Winter said that she was under the impression that O'Connor previously worked at Cumberland County Jail and was familiar with Wayne _Diffin. ADA Winter asked that I follow up with O'Connor to see what her nowledge of Diffin was and why she would ask if Diffin was the offender when Petrin told her story.

I contacted Sarah Petrin who confirmed that the male who was communicating with Diffin via her cell phone on the night of the assault was her current boyfriend Robert Emond (DOB 3/2/82; 207-383-0799). She said that Emond was with her and handed him the phone.

I introduced myself and asked Emond to explain the exchange he had with Diffin. He told me that he had texted Petrin earlier that day and then later he got a message stating that the author was "her new man and to leave her alone" as well as words to the effect of "she will be sucking my dick tonight". Emond said that he called the number (which would have been Petrin's phone according to all parties) and when Diffin answered Emond told Diffin something to the effect of "you can have her and all the bullshit" and to leave Emond alone. Emond said that the male did not respond to him and it was a short conversation. Emond told me that he did not save the text messages and has a different phone now. confirmed Emond's personal and contact information and thanked him for speaking to me.

I was dispatched to 30 Spring St. in Sabattus by the Lisbon Communications Center for a possible Domestic Violence Assault currently occurring. The LCC advised that the original call was from a third party (ex-boyfriend) in Auburn Maine who received a call from the victim, later identified as 36 year old Melissa Tuomivirta, DOB: 02/26/1977, of 30 Spring St. in Sabattus. The caller told the LCC that 33 year old Robert (Bobby) Emond, DOB: 03/02/1982, of 123 Vail St. #4, Lewiston, ME was "beating up" Tuomivirta. I responded to the scene with lights and sirens.

2. Upon my arrival I met with Tuomivirta who was visibly shaken. I immediately noticed Tuomivirta's face to be bright red, with bruising and abrasions on both sides of her neck. I noticed petechiae on both cheeks, ears, around the lips which were swollen, and opening to Tuomivirta's nostrils. Tuomivirta's voice was extremely hoarse and strained. I asked Tuomivirta if Emond was still in the house wherein she answered "no". I asked Tuomivirta to tell me exactly what happened. She told me the following in substance.

3. In the early morning of 02/09/2016 sometime near 05:00am, Tuomivirta and Emond, Tuomivirta's live-in boyfriend and intimate partner got into an argument when Emond became jealous over an unknown topic of discussion. Emond then forcefully grabbed Tuomivirta by the neck with both hands and strangled Tuomivirta to the point of unconsciousness while he restrained her to the couch inside of her residence at 30 Spring St. Tuomivirta described to me that she didn't remember if she went unconscious; however, she remembers that everything went black. Tuomivirta told me that she was terrified when this happened and she thought she was going to die.

4. Tuomivirta did not remember why Emond let her neck go, but she remembers that once he did, she attempted to get up. When she did this, Emond grabbed her by the arms and shook her while she attempted to get up from the couch. Tuomivirta told me that Emond shook her back and forth onto and off of the couch. Tuomivirta later showed me bruising to both of her arms where Emond had grabbed her, as well as on her back from where she was forced onto the couch. Tuomivirta also displayed bruising on her chest. 5. Tuomivirta told me that after the assault took place, Emond fled the residence. Tuomivirta said she thought Emond went to his cousin's house and gestured to 45 Park St. "the house with the lights on". Tuomivirta told me she knew there were firearms in the home and stated she knew Emond would have access to those weapons. Tuomivirta was very concerned as she knew Emond to me mentally unstable. I photographed Tuomivirta's injuries and requested United Ambulance Service to respond to the scene with the flow of traffic to the scene to evaluate Tuomivirta's injuries. Tuomivirta rendered a written statement and was provided information on protection from abuse order's and victim's rights forms. Tuomivirta also detailed to me that Emond traditionally became more and more violent as he drank alcohol. Tuomivirta told me Emond was in fact drinking alcohol prior to the index assault.

6. As Tuomivirta was writing her statement, a silver Ford Explorer left the 45 Park St. residence. Tuomivirta stated she thought that it was Emond attempting to flee. I pursued the vehicle and conducted a traffic stop on Main St. I approached the vehicle with my firearm drawn as I was unable to see inside the vehicle and rule out the presence of any weapons or the lack thereof. The operator was identified as Jody Moczara, DOB: 01/13/1981, of 45 Park St. After demanding to see her hands and clearing the vehicle I re-holstered my weapon. Moczara told me that Emond had walked to her house and told her that he and Tuomivirta had gotten into an argument and refused to say any more. Moczara told me that Emond was currently at her residence where there was a firearm, however she didn't think he knew where it was. Moczara told me she would go to the house with me where she would get Emond for me.

7. Moczara and I responded to the residence where she entered the home. I stayed in the driveway with concealment and the possibility of cover. Emond exited the house with his right hand in his jacket pocket. I had drawn my firearm and ordered Emond to remove his hands from his pockets, and drop the lighter in his hand. I ordered Emond to put his hands behind his back and drop to his knees after facing away from me which he complied with. At this point I placed Emond under arrest for Aggravated Assault, and Domestic Violence Assault.

8. I placed Emond in handcuffs which were checked for proper fit and double locked. Emond was placed in the rear passenger seat of my cruiser where he was seat belted in accordance with state law and agency policy. I then drove back to 30 Spring St. where I advised Emond of his legal rights, which he both stated he understood and waived, stating he would answer my questions depending on what they were. I asked Emond to give me his version of events wherein he told me, in very vague detail that Tuomivirta assaulted him before he put his hands on her to defend himself. Emond explained the bruising on Tuomivirta's neck was from where he bit her in the heat of passion during an earlier sexual encounter. Emond also had an explanation for the bruising on Tuomivirta's arms from where he restrained her during a medical episode where she began shaking uncontrollably. The longer that Emond sat in my vehicle the more apparent the odor of intoxicating liquor grew. Later Emond would admit to drinking several beers before the index assault. Emond then said the bruising on

Tuomivirta's chest and back was from where he pushed her away from him during her alleged attack. Emond was unable to explain the petechiae on Tuomivirta's body.

NOTE: Based on my training education and experience as a police officer, and through my specialized training relating to Domestic Violence Strangulation cases, I determined that Emond, despite his statements was in fact the predominant aggressor. I observed Emond to exert power and control over Tuomivirta during the index assault, as he attempted to control the outcome of the conversation he and I had. While talking to Emond it was clear to me that he was extraordinarily manipulative in the way he tried to portray himself in relation to others.

9. After interviewing Emond, I again met with Tuomivirta who had finished her statement. Tuomivirta also added before I left that at one point during the evening Emond told her that if she did not stay at the residence, someone would end up dead. Tuomivirta told me that Emond then glared at her making her believe that if she were to leave the residence Emond would follow through with his threat, killing her. I collected Tuomivirta's written statement and told her that I would be in touch and to call Sabattus Police if she needed any assistance.

10. I transported Emond to the Androscoggin County Jail where he was processed. I Completed the ODARA risk assessment for Emond which resulted in a final score of 7+. I issued Emond three Uniform Summons and Complaint citations for Aggravated Assault, Class B, Domestic Violence Assault, Class C, and Domestic Violence Criminal Threatening, Class C. All DV crimes were upgraded to Felony level based on Emond's conviction history. All USACs were issued with a pending 8th District Court date of 03/09/2016 at 13:00hrs. Emond endorsed all USACs with his signature promising his appearance before the court. Due to the severity of the charges, Emond was to be held without bail until a hearing before a judge. Emond's probation officer was notified via voice mail of this arrest.

4. Tuomivirta did not remember why Emond let her neck go, but she remembers that once he did, she attempted to get up. When she did this, Emond grabbed her by the arms and shook her while she attempted to get up from the couch. Tuomivirta told me that Emond shook her back and forth onto and off of the couch. Tuomivirta later showed me bruising to both of her arms where Emond had grabbed her, as well as on her back from where she was forced onto the couch. Tuomivirta also displayed bruising on her chest. Tuomivirta told me that this exact same type of behavior had happened on 02/08/2016 between her and Emond. Tuomivirta said that she had found out Emond was allegedly a "rapist" and mentioned it to him sending him into a tantrum. Tuomivirta also mentioned that Emond had been getting very sexually aggressive and forceful with her as well but not during this incident.

5. Tuomivirta told me that after the assault took place, Emond fled the residence. Tuomivirta said she thought Emond went to his cousin's house and gestured to 45 Park St. "the house with the lights on". Tuomivirta told me she knew there were firearms in the home and stated she knew Emond would have access to those weapons. Tuomivirta was very concerned as she knew Emond to me mentally unstable. I photographed Tuomivirta's injuries and requested United Ambulance Service to respond to the scene with the flow of traffic to the scene to evaluate Tuomivirta's injuries. Tuomivirta rendered a written statement and was provided information on protection from abuse order's and victim's rights forms. Tuomivirta also detailed to me that Emond traditionally became more and more violent as he drank alcohol. Tuomivirta told me Emond was in fact drinking alcohol prior to the index assault.

6. As Tuomivirta was writing her statement, a silver Ford Explorer left the 45 Park St. residence. Tuomivirta stated she thought that it was Emond attempting to flee. I pursued the vehicle and conducted a traffic stop on Main St. I approached the vehicle with my firearm drawn as I was unable to see inside the vehicle and rule out the presence of any weapons or the lack thereof. The operator was identified as Jody Moczara, DOB: 01/13/1981, of 45 Park St. After demanding to see her hands and clearing the vehicle I re-holstered my weapon. Moczara told me that Emond had walked to her house and told her that he and Tuomivirta had gotten into an argument and refused to say any more. Moczara told me that Emond was currently at her residence where there was a firearm, however she didn't think he knew where it was. Moczara told me she would go to the house with me where she would get Emond for me.

7. Moczara and I responded to the residence where she entered the home. I stayed in the driveway with concealment and the possibility of cover. Emond exited the house with his right hand in his jacket pocket. I had drawn my firearm and ordered Emond to remove his hands from his pockets, and drop the lighter in his hand. I ordered Emond to put his hands behind his back and drop to his knees after facing away from me which he complied with. At this point I placed Emond under arrest for Aggravated Assault, and Domestic Violence Assault.

8. I placed Emond in handcuffs which were checked for proper fit and double locked. Emond was placed in the rear passenger seat of my cruiser where he was seat belted in accordance with state law and agency policy. I then drove back to 30 Spring St. where I advised Emond of his legal rights, which he both stated he understood and waived, stating he would answer my questions depending on what they were. I asked Emond to give me his version of events wherein he told me, in very vague detail that Tuomivirta assaulted him before he put his hands on her to defend himself. Emond explained the bruising on Tuomivirta's neck was from where he bit her in the heat of passion during an earlier sexual encounter. Emond also had an explanation for the bruising on Tuomivirta's arms from where he restrained her during a medical episode where she began shaking uncontrollably. The longer that Emond sat in my vehicle the more apparent the odor of intoxicating liquor grew. Later Emond would admit to drinking several beers before the index assault. Emond then said the bruising on Tuomivirta's chest and back was from where he pushed her away from him during her alleged attack. Emond was unable to explain the petechiae on Tuomivirta's body.

NOTE: Based on my training education and experience as a police officer, and through my specialized training relating to Domestic Violence Strangulation cases, I determined that Emond, despite his statements was in fact the predominant aggressor. I observed Emond to exert power and control over Tuomivirta during the index assault, as he attempted to control the outcome of the conversation he and I had. While talking to Emond it was clear to me that he was extraordinarily manipulative in the way he tried to portray himself in relation to others.

9. After interviewing Emond, I again met with Tuomivirta who had finished her statement. Tuomivirta also added before I left that at one point during the evening Emond told her that if she did not stay at the residence, someone would end up dead. Tuomivirta told me that Emond then glared at her making her believe that if she were to leave the residence Emond would follow through with his threat, killing her. I collected Tuomivirta's written statement and told her that I would be in touch and to call Sabattus Police if she needed any assistance.

10. I transported Emond to the Androscoggin County Jail where he was processed. I Completed the ODARA risk assessment for Emond which resulted in a final score of 7+. I issued Emond three Uniform Summons and Complaint citations for Aggravated Assault, Class B, Domestic Violence Assault, Class C, and Domestic Violence Criminal Threatening, Class C. All DV crimes were upgraded to Felony level based on Emond's conviction history. All USACs were issued with a pending 8th District Court date of 03/09/2016 at 13:00hrs. Emond endorsed all USACs with his signature promising his appearance before the court. Due to the severity of the charges, Emond was to be held without bail until a hearing before a judge. Emond's probation officer was notified via voice mail of this arrest.
